SUBJECT: NOTICE OF ELECTION FOR THE ELECTORAL COLLEGE MEMBERS Following the nullification of the Electoral College Member election by the Election Appeals Committee on 21st February, 2024 via a memo referenced (MMU/EAC617/001/VOL.1(01), the delegate election stands nullified.

However, article 25 (2) of the MMUSA constitution mandates the Chairperson of the Electoral Commission to issue a notice of elections within 7 (seven) days after the earlier election. Therefore, this is to issue a notice for election for delegates from the 16 academic departments. Nomination and clearance forms will be issued on 23rd February, 2024. The deadline for submission of the nomination forms will be 27th February, 2024, 3pm at Serengeti common room.

Qualifications for election to the student electoral college are as follows:

- a) Is a bonafide student of "MMUSA".
- b) Is registered in the Electoral College area (department) the member seeks to represent.
- c) To contest as a prospective candidate should demonstrate that they have cleared (60%) school fees.
- d) To contest a prospective candidate should demonstrate that class work would not suffer by obtaining an average mean mark of credit pass (60%) for normal students and (50%) for the disabled in the previous University examinations. The fulfilment of this requirement shall be confirmed by the Registrar Academic (Article 19 (7)).
- e) A first-year student intending to contest should have obtained a credit pass of (60%) average of **half units** of the CAT marks. The fulfilment of this requirement shall be confirmed by the Deans of the respective Schools (Article 22 (3 & 4)).
- f) Not be a member of "ISEC".
- g) Not have been proven guilty in a disciplinary case in the University.
- h) Not have held a position in S.C for two terms in "MMUSA" or any other university in Kenya.
- i) Each candidate should be endorsed by registered total number of 200 students' signatures for the position of departmental delegate (Article 22 (8)).
